New Stericycle Customer Labels Required for Container Pickup!

Beginning September 5th, 2023 all waste containers picked up and processed by Stericycle are required to use our new color-coded container labels.

The new labels include the following features:

- Color-coded by type of waste
- Your NEW customer account numbers
- A unique identifier code to identify each container
- A QR code for fast service scanning and accurate chain of custody tracking – QR code for Stericycle use only!



The new Stericycle waste labels help us ensure the full chain of custody tracking for your medical waste and provide safe, secure and compliant processing of all waste.

How will I receive my new labels?

Labels for your first service after September 5th will be provided to you between August 22nd and your first service in September. These new labels should not be used prior to September 5th. Any containers picked up on September 5th or after must use the new labels.

Where do I place the new labels?

Refer to the placement guide on the front of this flyer for accurate label placement. Remember that only one label should be placed on a container to eliminate confusion.

How do I know which type of waste goes with each label?

There is a reference photo on the back side of this flyer which shows the colors for each label and the type of waste which should be labeled with each color.

How do I request and receive additional labels beyond the supply first delivered to me?

You may request additional labels at any time by calling 866-783-7422. You may also ask your driver to request labels when they come to your site for service pickups. Please plan ahead to make sure you have labels before your pickup service.

Can I still use my old labels?

After September 5th your old labels will no longer be accepted on containers. If you have a supply of old labels you may shred them at your office or you may give them to your driver for disposal.

Waste Generator Labels

Federal regulations require all regulated waste generators to label waste containers prior to pick-up and transport for disposal.

As your waste management partner, Stericycle provides you with color-specific labels with key information for proper compliance, transportation, and disposal. The label color indicates the type of waste in the container. The label also includes:



- Waste generator name, address, and phone as well as your Stericycle customer number
- Waste transporter name, address, and phone your Stericycle location
- Stericycle-specific QR code allows for waste and container tracking
- Space to enter waste pick-up date
