



Hazardous Waste Manifest Guide



WHAT ARE HAZARDOUS WASTE MANIFESTS

A hazardous waste manifest is a document containing information about the type and quantity of hazardous waste being transported. It is used to help track hazardous waste from its point of generation to its end disposal location and helps inform those handling the waste along the way how to properly manage it.

Use of a hazardous waste manifest is required for anyone who transports, or offers for transport, hazardous waste. The hazardous waste manifest requirements are primarily set by the U.S. Environmental Protection Agency (EPA) and the U.S. Department of Transportation (DOT). Some states have unique regulations, but this guide focuses on federal hazardous waste manifesting requirements.

MANIFEST REQUIREMENTS

It's the shipper's responsibility to prepare the appropriate shipping documentation for each shipment of hazardous waste. The manifest must include information about the generator, properly describe the hazardous waste being transported, and be signed by the generator along with each transporter.

Generators are responsible for training employees who prepare and handle hazardous waste, including the person who signs the manifest on behalf of the generator.

RECORDKEEPING

All parties involved in the hazardous waste chain of custody must retain copies of the manifest for at least three years (state requirements may vary).

The EPA launched an electronic manifest system (e-Manifest) in 2018, and strongly encourages generators to switch to e-manifests from paper manifests.

X IMPORTANCE OF GENERATOR CERTIFICATION AND SIGNATURE

Each person who offers a hazardous waste for transportation must certify that the contents of the shipment are fully and accurately described, that the waste is appropriately classified, packaged, marked and labeled/placarded, and that the waste is in all other respects in proper condition for transport. The certification must be signed by a principal, officer, or employee of the shipper or his agent. The shipper may **not** offer a hazardous waste for transport unless the shipper has prepared a **properly completed manifest**.

**Hazardous waste is different than regulated medical waste (RMW), which is a hazardous material. RMW shipping papers are not equivalent to hazardous waste manifests and are outside the scope of this guide.*
